Call to Order – President Tom Blackburn called the meeting to order at 7:35PM.

**Approval of Agenda** – R. Keen moved to accept the agenda with the addition of a discussion of the T-shirt project and approval of the confirmands. A. Pankake seconded. Approved

#### **Action Items:**

- Member Follow-Up intentional follow up with members we haven't seen in worship, and those who need encouragement Sue Gasswint will send thank you notes to youth advisors, Bonnie Barton, Carolyn Houck and Chris Jury.
- New Council members acceptance of candidates The following have agreed to serve: Brett Weber, Nevin Shenk and Marti Bert. Pastor will follow up with Ben Galle and Terry will follow up with Cody.
- June Congregation annual program meeting. R. Keen moved to schedule the meeting for June 23<sup>rd</sup>. N. Whitcomb seconded. Approved. Liaisons will reach out to committee chairs and ask them to send in their annual reports to the office by June 3<sup>rd</sup>. Council candidates should also submit brief bios.
- Van Repairs there was an issue with the steering mechanism. It has been fixed and expect a bill of about \$600. S. Gasswint moved that the bill expected to be no more than \$600 be paid out of Council Endowment. M. Bert seconded. Approved.
- T-Shirt Discussion Adam Pankake shared information about the Grace ELCA shirts. The pricing he received is based on an order for 25 T-shirts at \$8each, 20 hoodies at \$19 each, 20 polos at \$15each. The minimum order for each type of shirt is 12. Grey is the color with blue logos. Bill Shear is the vendor. Our goal with this project is evangelism.
   M. Bert moved and P. Rohde seconded a motion to spend \$950 out of Fund 2 misc. to purchase 25 T-shirts, 20 hoodies and 20 polos. Approved. Orders for shirts should be placed with Adam Pankake.
- Update Deacon Molly. Deacon molly is back to work an average of 10 hours per week. She will work through the end of her contract (June 9). She is not doing pastoral care

tasks or visiting of shut ins or hospital visits. Her last Sunday at Grace will be June 2<sup>nd</sup>. There will be a farewell wine and cheese on Saturday June 1. On Sunday June 2nd there will be a blended service at 9:30AM and a brunch. Pastor ordered a red stole at a cost of \$130 as a gift from the council. R. Keen moved and T. Alfano-Douty seconded a motion that council provide a gift of \$500 and the stole that has been ordered with the funds coming from Council Endowment. Approved.

## C. Vice-president's Report

a. Call Committee. The committee has met with the Synod representative and met for a second time to work on the profile. A third meeting is scheduled, and the focus of that meeting will be the survey of the congregation (offered online and in print) and setting up small group discussions. After the meetings and profile are finished, the profiles come to Council for approval before being sent to the Synod. At that point we will begin receiving information about candidates.

#### B. Treasurer's Report

- a. Audit Committee Met on Thursday night, May 9<sup>th</sup> for the first time.
- b. Capital Campaign Update Loan balance is \$83,809 as of May 12. Approximately \$380 interest per month is being paid from Fund 1. Pledges come into Fund 2 monthly and are accruing. Before the principal of the loan comes due Council will need to decide how to pay off the loan.
- c. Monthly Report reviewed P. Rohde moved to accept the Treasurer's report. R. Keen seconded the motion. Approved.

- a. Pastor highlighted that there is a new Connect policy that a staff member or council member who is a mandatory reporter must be present at the service for worship to occur.
- b. Discussions have been held about following the policies in place for children's protection in the Sunday School program.

- c. Marti Bert will write a letter to the field education department of the Seminary at Gettysburg regarding the basic procedures to follow before sending seminarians out on field education. Pastor Cover will edit and send.
- d. Office Update: Diane will be out for a medical procedure and there is overlap with Wendy's vacation the week of June 10<sup>th</sup>. It may be that the office is closed during that overlap time due to coverage issues. Sue Gasswint may be able to provide some coverage. Bonnie Barton will help with the newsletter production.
